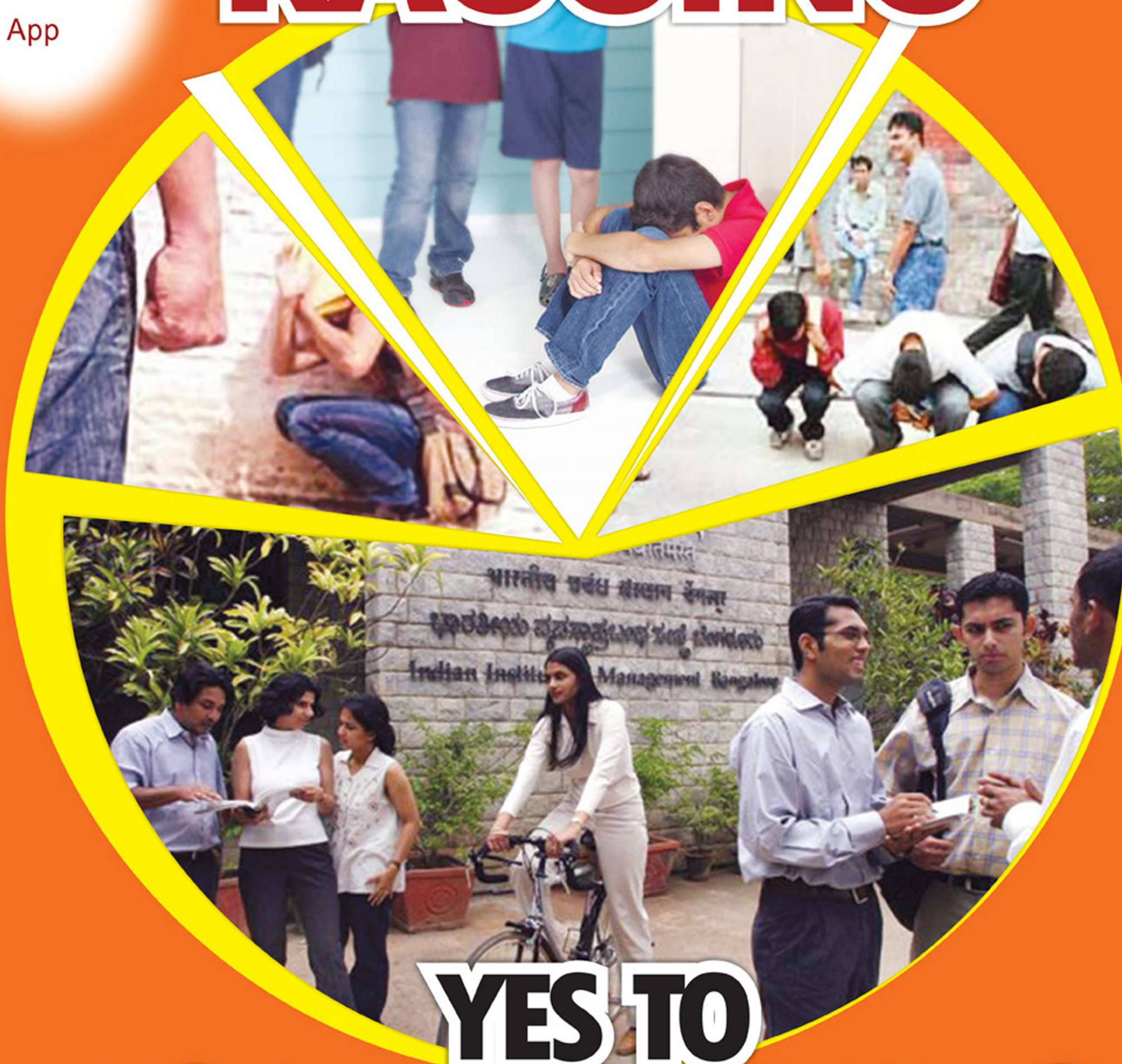

What is Ragging?

Any Act Resulting in:

- Mental/physical/sexual Abuse
- Verbal Abuse
- Indecent Behaviour
- Criminal Intimidation/wrongful Restraint
- Undermining Human Dignity
- Financial Exploitation/extortion
- Use Of Force

A STUDENT INDULGING IN RAGGING CAN BE:

- Cancellation of admission.
- Suspension from attending classes.
- Withholding/withdrawing Scholarship/Fellowship and other benefits.
- Debarring from appearing in any test/ examination or other evaluation process.
- Withholding results.
- Debarring from representing the institution in any regional, national or international meet, tournament or youth festival etc.
- **Collective punishment** : when the persons committing or abetting the crime of ragging are not identified the institution shall resort to collective punishment as a deterrent to ensure community pressure on potential ragger.

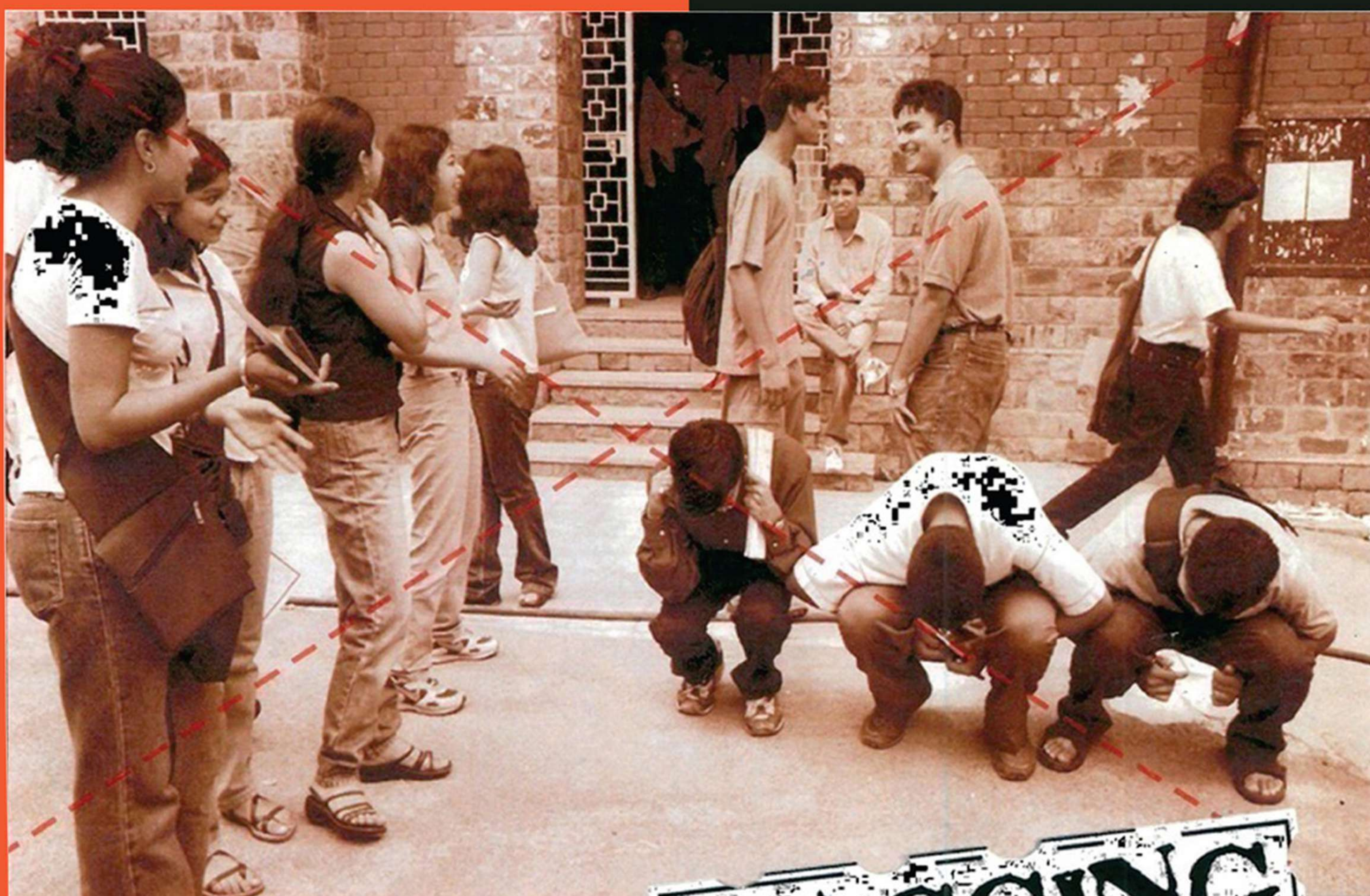

ANTI-RAGGING RULES & REGULATIONS

1. INTRODUCTION

Guru Nanak Girls' P.G. College, Udaipur follows a strict zero-tolerance policy against ragging. The institution adheres to:

- UGC Regulations on Curbing the Menace of Ragging, 2009
- Supreme Court of India guidelines
- Government of Rajasthan directives

Any student found involved in ragging shall face immediate disciplinary and legal action.

2. DEFINITION OF RAGGING

Ragging includes:

- Verbal, physical, or psychological abuse
- Teasing, mocking, or humiliating a student
- Forcing a student to perform tasks that cause embarrassment
- Harassing a student through comments, threats, or behavior
- Creating fear, intimidation, or a hostile environment
- Online or cyber ragging through messages, posts, or social media

3. PROHIBITED ACTIVITIES

The following acts are strictly prohibited:

- Bullying, threatening, or intimidating juniors
- Forcing fresher's to buy items, run errands, or perform tasks
- Public humiliation or insults
- Restricting movement or isolating any student
- Physical assaults or abusive behavior
- Demanding money, gifts, or favors
- Online harassment via WhatsApp, Instagram, etc.

4. PUNISHMENTS FOR RAGGING

Depending on severity:

- Warning or reprimand
- Suspension
- Cancellation of admission
- Debarring from exams
- Rustication
- Police complaint under IPC
- Penalties under UGC regulations

5. ANTI-RAGGING COMMITTEE/ SQUAD

Includes:

- Principal (Chairperson)
- Senior Faculty Members
- Counselor

6. MANDATORY STUDENT UNDERTAKING

All students and guardians must submit an annual Anti-Ragging Undertaking.
